



## 2021 SUPPLEMENTARY REGULATIONS FOR MG CAR CLUB SYDNEY, SUPERSPRINT: PHEASANT WOOD, MARULAN

**Authority**: Event is held under an A.A.S.A permit and Standing Regulations for Speed Events, these Supplementary Regulations, and any further regulations issued by the organising club.

#### 9. Event Format

Cars will be divided into groups of Vehicles based on previous lap times recorded at the same circuit (or other circuit as advised) in the same vehicle. Group 1 will be for Open Wheel and Clubman Style Vehicles (lightweight with little protection). Where possible, similar types of vehicles will be grouped together in the event where a driver has not competed at the track before. He/she will be placed in the "First Timers" group to determine their appropriate group, or if times are available from another circuit then they may be placed in a group relative to those lap times.

### ALL VEHICLES will be Gridded Fastest to Slowest

Cars may be started in pairs. The maximum number of cars will be 10 in each group.

Each run will comprise of **6 minutes**, from the time the first competitor passes the timing point with the time for the fastest single lap being used for results. This will NOT include the warm up and cool down laps. *This 6-minute interval may be extended* 

to a longer duration (such as 8 mins), depending on lack of delays and less drivers as the day progresses, with a P.A. announcement to drivers by the Clerk of Course

Proposed minimum number of runs on the day will be 4.

(Note: The Event will not be concluded when this minimum is achieved. Event will only be concluded early for safety reasons or if no competitors are available).

Note: Grouping of cars to form a 'mini-race' anywhere on the circuit and "diving inside under brakes" is <u>NOT</u> permitted, and action will be taken by the Clerk of the Course if such an incident takes place.

#### 10. Familiarisation Session.

There will be no familiarisation laps. Drivers that have not previously competed at the track must advise the Secretary of the Event prior to Event. If they have competed at another track, those times will be assessed and the driver will be placed at the rear of an appropriate speed group. Those with no advised times will be placed at the rear of the slowest group. All first time drivers will have an additional safety address after the drivers' briefing (or drivers' handout briefing for reading).

#### 11. Entries.

Entries will be accepted in order of receipt when all information requested is supplied to the Secretary, and with correct payment credited to MGCC for the appropriate fee(s).

a) Maximum number of Driver entries for the Event: 60 Reserves: 10

- b) Maximum number of Drivers per competitor (car) 2. Dual entry acceptance will be at the discretion of the club.
- c) Drivers must be a member of the listed Invited Clubs:

d) General Entry Opening Date: 30th March 2021

Entry Fee: \$165 per driver

- e) Electronic "MY LAPS" Timing Transponder IS INCUDED IN THE ENTRY FEE. Please ensure that the unit is mounted correctly.
- f) Closing Date: Thursday 15<sup>th</sup> April 2021 A late entry fee of \$20 will apply for entries received after the closing date.
- g) Carports are available on a first come basis, and are INCLUDED IN THE ENTRY FEE. Car Trailers are to be removed back out of the pits into the designated Trailer Parking Area
- h) Entries will be accepted in order of receipt via completing the MGCC Entry Form Round 2 accompanied by the appropriate entry fee. NOTE: Direct Deposit is the only form of Payment Accepted.

- Entries from Drivers under 18 years of age must be counter-signed/consented by a parent or legal guardian on the official entry form.
- j) The Organisers reserve the right to refuse any entry without giving a reason. An email confirming acceptance of entries will be sent to each competitor (only for entries received more than 4 days before the event).
- k) If a competitor advises the event secretary that he/she is unable to attend the event, the following procedure regarding a refund applies: More than 5 days prior to the event full entry fee less \$20 for administration, with a 50% refund applying within 4 days. No refund for cancellation on the day.
- I) Any vehicle presented for scrutineering will for the purpose of the entry be deemed to have competed.

#### 12. Minimum Licences:

A.A.S.A. Club Licence or equivalent recognized by AASA (eg Motorsport Australia Level 2S Licence or above) and club membership card proving current membership, <u>are compulsory and must be produced on the day of the Event, to be allowed to compete.</u>

#### 13. Drivers Safety:

- a) All drivers and passengers shall wear apparel including helmets which comply with AS1698 or better. Helmets must be in good condition with no visual signs of damage.
- b) Frontal Head Restraints (FHR) must be used in accordance with Schedule D Table 1.4 of the 2021 Motorsport Australia Manual, which can be found on the Motorsport Australia website at www.motorsport.org.au: Schedule D Table 1.4 of the 2021 Motorsport Australia Manual.
- Non-flammable Clothing must be worn that extends from ankles to neck to wrist. Clothing of flammable synthetic material such as nylon is not acceptable. The onus will be on the competitor to prove that older overalls/suits still have fire-resistant properties and are not impregnated with oil or fuel.
- d) Flame retardant underwear and socks is not mandatory however they are recommended. A Flame-retardant balaclava is not mandatory however, a motor sport standard flame retardant balaclava is recommended.
- e) Shoes compliant with FIA8856-2000 or shoes which completely cover the feet, made entirely of leather or other flame-resistant material must be worn. Shoes which have a leather upper but which includes elasticised ankle regions are acceptable. Shoes that contain any synthetic materials such as nylon are not acceptable.
- f) Gloves are not mandatory, however the use of FIA- standard flame-retardant gloves are strongly recommended.
- g) For a driver of an open car, a full-face helmet is highly recommended. Goggles or a visor with a lens material other than glass (ie to AS1609- 1981) are mandatory as are leather or Nomex gloves which entirely cover the hands.
- h) Closed vehicles that do not use a window net MUST drive with the Driver's window in the UP position, in case of rollover.
- 14. Vehicle Categories & Classes: NOTING THAT ELECTRIC VEHICLES CANNOT BE ACCEPTED

As per the attachment located at the bottom of this document marked "CSCA CLASS TABLES for 2019 r1",

Note: Rotary and forced induction engines are subject to <u>capacity multipliers</u> as follows:

Rotaries - multiply by 1.8

Forced Induction - multiply by 1.7

Forced Induction Rotaries - multiply by 3.06

ELECTRIC VEHICLES are not permitted due to additional Safety Requirements & Officials Training.

Note: The Organisers may re-classify any vehicle if they believe it is not eligible for the class in which it has been entered.

- 15. Self Scrutineering and Spot Check Requirements: ALL Entrants are required to complete a SELF-CHECK SCRUTINEERING FORM, AND SCAN AND RETURN THIS FORM BY EMAIL TO THE EVENT SECRETARY!
  - a) All vehicles are to be presented at the track ready for spot scrutineering checks at any time, and must comply with standard Supersprint Requirements:
    - A fire extinguisher (minimum 900g to AS1841), securely fitted within reach of the driver

- A blue triangle, 150mm on each side mounted to indicate the battery location.
- A secondary method of securing the bonnet. **Note:** Road registered cars fitted with the original manufacturers 2 stage bonnet locking system is considered as having two securing systems.
- All forward facing glass lenses to be completely covered by a protective film.
- All loose objects are to be removed from the car.
- The battery is to be firmly clamped.

Competition numbers are to be positioned on both sides of the vehicle, on the door and of a height no less than 28 centimetres and must be clearly legible to the timekeeper and be of a contrasting colour to the surrounding bodywork. Dual entry numbers must be shown to the scrutineer. Self Adhesive Numbers will be available on the day @ \$2.50 each. Windscreen Numbers are preferred at this Venue. Magnetic Nos need to be taped as well.

NOTE: To help the Secretary and reduce your cost, we recommend a CSCA "Permanent" Competition Number be RESERVED if you plan to continue competing in CSCA events!!

- b) **Drivers and vehicles must be presented in a clean and tidy manner**, completely ready for the track including the driver's apparel and helmet. Any tyre or component changes to the vehicle after scrutineering must be approved by the Chief Scrutineer before the vehicle is taken onto the track.
- c) Any vehicle found to be leaking oil or fluids whilst competing will be suspended from the event until the Chief Scrutineer / Clerk of the Course is satisfied that action has been taken to rectify the leak. Should there be a reoccurrence of the leak then the vehicle will be excluded from the remainder of the event. Clean up of the fluids spilt on the track will be at the driver's expense.
- d) All vehicles must be fitted with visible towing hooks or a similar device both front & rear to allow for the speedy removal of a vehicle from a "sand trap" or removal from the circuit in the case of a mechanical failure.
- e) All video cameras, data loggers & other electronic devices must be securely fixed to the vehicle in accordance with the manufacturer's instructions. Where suction cups are used a secondary tether sufficiently strong enough to prevent the item moving within the vehicle should the suction cup/s release should be used.
- f) A sticker will be issued confirming that the vehicle has passed **self scrutineering checks** permitting it being able to compete. We envisage ALL cars & apparel will be spot checked during the day. Any car may be prevented from competing ON THE SPOT by the Scrutineer, if serious issues are found during the Spot Checks.

(It is recommended that this scrutineering sticker be taped on to prevent it being blown off).

#### 16. Noise:

#### Maximum Noise Limit: 95 dba at 30 metres.

Any car found to exceed the maximum noise emission limit will be suspended from the event until the Chief Scrutineer / Clerk of the Course is satisfied that action has been taken to bring it within the limit. Any vehicle that exceeds the limit on two runs will be excluded from the remainder of the event. If a vehicle exceeds the noise limit on any lap or laps within a run, then only those laps in which the vehicle conformed to the requirements will be allowed for the purpose of the results.

#### 17. Pre-Event Scrutineering:

All competitors must complete the online vehicle declaration and self-scrutineering check by 15th April 2021.

<u>Note:</u> It is the Drivers' responsibility to ensure their vehicles are self-scrutineered. On the day of the event our Chief Scrutineers will be doing spot checks based on submitted vehicle declarations. The driver must attend spot scrutineering personally so that their vehicle can be checked.

Administration will open 8:00am – 9.15am in the covered area adjacent to the Control Tower. After 9:15am, you will need to attend the base of the control tower. All drivers must attend to get their wrist band, scrutineered sticker and licence & club membership currency checks.

**Drivers' Briefing:** It is compulsory for **ALL** Drivers: All drivers must confirm the reading of an online Drivers' Briefing Form supplied prior to the event. Note: If NSW COVID Rules allow for a gathering at Marulan, an in person drivers' briefing will take place, whilst maintaining minimum separation distances as required. A Bulletin will be Issued if this is the case, and an in person briefing can take place.

<u>Note</u>: All Drivers must acknowledge reading of the briefing to prove Briefing attendance, failure to do so may result in penalties being applied by the Stewards of the Meeting. The Organising Club must retain these records for any incident or accident reporting.

- 19. Event Schedule: Start time: 9:30am Finish time: 4:30 pm
  It is requested that all vehicles in Group 1 form their vehicles up on the dummy grid after sign on checks, so that there is no delay to the start of the Event.
- 20. Replacement Vehicles: At the sole discretion of the Clerk of the Course, a Driver whose vehicle has broken down may use a replacement vehicle. The replacement vehicle must have been scrutineered, and preferably be in the same class and type as the original vehicle. Where the original vehicle has recorded a time and the scrutineered replacement is not in the same class and type as the original vehicle, the replacement vehicle will not be eligible for prizes and/or trophies.
- 21. Timing Equipment and Accuracy:

Timing will be "MY Timer" Timing Units only (no Dorian Timers will Operate) and to an accuracy of 0.001 seconds. The compulsory My Timer Timing unit is included in the Entry Fee. Each Competitor MUST have a "My Timer" unit to have lap times recorded.

22. Results:

A set of results will be emailed to all competitors after Class ratification by CSCA Delegates. Results will be available after ratification on the **www.natsoft.com.au** website.

- 23. Prizes / Awards: Recognition will be awarded as per CSCA guide lines.
- 24. Authority of Officials: Any Driver not following a reasonable instruction by an official during the event may be excluded at the discretion of the Clerk of Course of the Meeting. The Clerk of Course (and Steward if attending) are deemed "Judges of Fact".
- 25. Medical Facilities: Ambulance Services Australia. Phone: 1300 762 626
- **26. Crash Rescue and Fire Fighting Facilities:** Wally's Motorsport will be in attendance on site. The Principal in Mr Wally Black with 25 years of Fire and Rescue Recovery experience. Motorsport Australia Silver Licence 9768926. Mobile phone No 0414750143. Fire extinguisher equipment will be located at nominated Flag Points on the circuit.
- 27. Insurance: Public risk insurance is provided by A.A.S.A.
- 28. Personal Accident Contribution: Personal Accident Contribution is provided by A.A.S.A.
- 29. Protests: Any protests must be made to the Clerk of Course.
- 30. Postponement/Abandonment/Cancellation: The organisers reserve the right to postpone, abandon or cancel the Event.
- **31. Use of Prohibited Substances:** During the event consumption of alcoholic beverages in the paddock, pits or any part of the competition venue under the control of the officials is expressly forbidden until the practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate in the event.
- 32. Refreshment Facilities Available: Provided by the Pheasant Wood Cafe.
- **Additions and/or Alterations:** Any additions and/or alterations to these Supplementary Regulations will be notified to all Drivers in the Final Regulations or during the online Drivers' Briefing.
